(Note1) In situations where LRA appoints multiple compliance officers, LRA will select one Chief Compliance Officer among all of the Compliance Officers. As outlined in the "Change in Key Employee" table above, going forward there will be three compliance officers and among the compliance officers, Takuma Taki will be the Chief Compliance Officer.

(Note2) The Chief Compliance Officer and each of the Compliance Officers are going to work part time and will rotate as the Compliance Officer of LRA during regular business hours.

Additionally, in accordance with the provisions set forth within the Financial Instruments and Exchange Act, the Building Lots and Building Transactions Business Act, as well as other applicable laws and regulations, LRA will continue to carry out all necessary notifications and procedures.
